The contest will be held as a SOLO contest, using the Guitar Hero 5 – Sony X Box 360 console, **No playing** on Career mode, changing characters, guitars etc.

1. You may not bring your own equipment or enter any cheat codes.
2. This tournament is open to all ages but if under 18 a parent or legal guardian must sign. All applications must be completed.
3. Scoring will be based on the highest scores as played by contestant.
4. You will only compete against other players on that level.
5. These winners will be asked to come back Saturday to compete in the finals.
6. ALL Finalists, will compete in their assigned skill level for the finals.
7. No restarts or retry's (unless directed by the host for technical reasons.)
8. Anyone blatantly damaging any of the equipment will be financially responsible to replace the broken equipment.
9. Anyone found violating these rules will be disqualified.
10. Rules are subject to change/be amended as needed, any amendments to the rules shall be posted at the event.
